Dear partners at Lawson Lundell LLP:

Thank you for your letter dated January 8, 2016 responding to my letter of December 3, 2015 to Mr. Rick Mahler, Chairman of the Board for British Columbia Investment Management Corporation, hereinafter BCIMC.

Mr. Mahler and his colleagues on the Board of Directors at BCIMC have wisely sought advice from Lawson Lundell, L.L.P., a law firm with a well-earned reputation for dispensing intelligent and competent legal counsel.

The partners at Lawson Lundell have, I am sure, advised Mr. Mahler and his colleagues that valid title to property cannot be lawfully acquired through a court order that was obtained as a result of the "terrorist" conspiracy that was developed as part of the BCIMC real estate acquisition plan that included the deliberate and fraudulent interference with the administration of the judicially supervised sale process.

The recent murder attempts made on the life of Mr. John English are a corroboration and continuation of the BCIMC "terrorist" strategy.

These facts have been communicated to BCIMC, the RCMP, the Ministry of National Defence and the Provincial Cabinet.

These facts are well publicized on the blog set up to support Mr. English and his family.

These facts are not denied or seriously challenged by your client(s).

It is trite law but a court order obtained as part of a criminal conspiracy is null and void in the eyes of the law. Therefore, BCIMC and its subsidiary cannot lawfully pass title to the subject property to any third party in Canada or elsewhere.

Further, the possession of property that the possessor knows was obtained by or derived directly or indirectly from the commission in Canada of an offence punishable by indictment is an offence under section 354(1)(a) of the **Criminal Code of Canada** and in this case an indictable offence carrying a ten year penalty.


Facts have now emerged that make it plain that BCIMC did not act alone in the criminal conspiracy to acquire the English family property and that other agencies of the

Government of British Columbia, such as the Ministry of Aboriginal Affairs, were also deeply involved.

Accordingly, would you kindly advise as follows:

1. Have the partners at Lawson Lundell LLP or their clients, Mr. Mahler and his colleagues on the Board at BCIMC, communicated the contents of my correspondence to Minister of Finance, Michael De Jong and / or his cabinet colleagues for appropriate consideration?
2. Do any of the partners at Lawson Lundell LLP act for any other agency or person occupying an office with the Government of British Columbia in respect of the matters that are under consideration in my correspondence and, if so, who or what is that agency or person?
3. Have the partners of Lawson Lundell, LLP, now become a party to the criminal conspiracy against the English family by advising its client to retain possession of what is clearly property derived directly or indirectly from the commission of an indictable offence in Canada?
