ON THE APPLICATION of the plaintiff coming on for hearing at the New Westminster Law Courts on the 13th and 14th days of January 2022, and on hearing Sanjeev K. Patro appearing as counsel for the Plaintiffs, Canada Easy Investment Store Corporation and Ralph van der Walle and no one appearing for the defendant, Daryl Macaskill, although duly served; via MS TEAMS:

THIS COURT ORDERS THAT:

1. The Defendant, Daryl MacAskill to pay
 - a. general damages of \$75,000 to the Plaintiff, Ralph Van der Walle ("Mr. Van der Walle") and a further \$75,000 to the Plaintiff, Canada Easy Investment Store Corporation ("Easy Invest").
 - b. aggravated damages of \$5,000 to Mr. Van der Walle and a further \$5,000 to Easy Invest.
 - c. Punitive damages of \$15,000 to Mr. Van der Walle and a further \$15,000 to Easy Invest.
2. The Defendant, Daryl Macaskill, is permanently restrained from publishing any accusatory or disparaging allegations regarding the honesty, trustworthiness, reputation, or alleged improper behavior of the plaintiffs, their counsel, and their agents (The "Protected Parties"), in any forum whatsoever.

3. Upon being presented with a copy of this Order, Daryl Macaskill is required to forthwith remove all current or existing posts about the Protected Parties from the Gangsterism Out and the Dr. Stoxxman Blogs.
4. The Defendant, Daryl Macaskill, is permanently restrained from contacting, directly or indirectly:
 - a. any known or purported business partners, investors, or clients of Canada Easy Investment Store Corporation or the Western Canada Monthly Income Fund; and
 - b. any of the individuals listed in term 3(b) of Blok J's order dated 14 October 2021 being: Adrian Harvey, Ralph van der Walle, Warren Stevenson, Michael Fowler, Sean Zubor, Viet Do, Kellye White, Michael Warsh, Stuart Wood, Duncan Magnus, Magnus Law, Warsh Law, Stonehaus Realty Corp., Studio AE Interior Design Inc., Liberty Mortgage Corp., Island West Coast Developments Ltd.
5. Mr. Macaskill shall only communicate with the Plaintiffs, Canada Easy Investment Store Corporation and Mr. Van der Walle, via email through their counsel Mr. Patro, and any such communications will be limited to no more than two emails per day, and must be devoid of any racist, sexist, or disparaging remarks, and must pertain only to the litigation in the current action or any related proceedings.
6. An entered copy of this Order must be served on the defendant, Mr. MacAskill, via email at drstoxxman@gmail.com within seven days of the Order being signed and entered with the Court.
7. The Plaintiffs are awarded their costs of the action as special costs, including special costs of the action up to and including 2 February 2022.
