Preface

I've been throwing the idea around of writing a book for several years now. I didn't want it to be about gangs and drugs, I wanted it to be about a road trip on my motorcycle. Something positive. Now I'm thinking I might write two. One about a road trip and another about my blog.

This book is about connecting the dots between politics and organized crime and the absolutely bizarre political stunts we're witnessing in the post Covid era with Trump 2.0 and the UN's New World Order.

Someone recently asked me how the Vancouver gang war has changed from when I started the blog in 2009 after the Surrey Six to now. This book

answers that. How we've gone from Hells Angels drug trafficking to Intelligence Agency extortion. Times have changed in a very big way. Warning. This book is filled with conspiracy theories. Now a conspiracy theory is exactly that, a theory which is an unproven hypothesis based on facts, motive and possibilities like the theory of evolution. Theories are then tested and proven or disproven.

Yet theories or hypotheses form the basis of the scientific method. It's how we solve mysteries so it is. Without theories or hypotheses we would never make any scientific advancements or solve any crimes. So let's dive in.

The Vancouver Gang War and the Surrey Six

Let's start with the Vancouver Gang War since that's where the Gangsters out Blog started. October 19th 2007 there was a ruthless gang murder that rocked my home town called the Surrey Six. Six people were executed in a Surrey condo. Four were gang members, two were innocent victims.

The outrageousness of executing innocent people for being witnesses created a public outcry that continues to this day. In the /80's I was a regional coordinator for a volunteer group called the Guardian Angels. I made a couple trips to New York City and met the founder, Curtis Sliwa and worked with the dynamic local leaders he had in New York.

After doing a significant amount of travelling I retired from the group, got married and had two children. Then several years later Curtis Sliwa came to Vancouver and asked me if I would help David Toner start a new chapter of the Guardian Angels in Vancouver.

David was high profile. His step son was brutally beaten to death at a Sky Train station in Whalley now known as Surrey Central. David was a good man. I liked him and said yes. I didn't want to have to do everything but I certainly didn't mind helping David in a good cause.

So we started putting pressure on the crack dealers at Surrey central. It was too big of a problem for two guys to fix so we decided to make a dent in their business. Every Friday night for a few hours we would patrol the area and make our presence known. We'd stand beside the crack dealers and make them feel uncomfortable.

They'd come up to us quite nervous and ask are you a cop? No, I'd say. I'd point across the street and say my friend's son was murdered right there and I'm here to make sure that never happens again. We'd loop the block and make our presence known. In a short time we saw a very dramatic response.

Back in the /80's when the Guardian Angels first started in Surrey there was a group of street rats who got on the news and called themselves the Whalley Burnouts. After a few strategic tactical patrols of the Guardian Angels in Surrey they disappeared. This time it was very different.

This time we'd see grown men in SUVs get in our grill, start to harass and try to intimidate us. I'd snap into New York mode and respond with something witty and aggressive to show them we were not impressed or intimidated. This continued to escalate.

Then one day a guy walks up to us with a crack dealer. He shakes my hand, introduces himself then asks me who we were and what we were doing. So I told him. We're here to stop violent crime and mentioned the murder of David's son. Then he responds we do that. I'm like great, the more people that stop violence the better.

Then he's all like well you better not get involved in our business. I was somewhat naive and didn't really have a clue what he was talking about so I just kind of sluffed it off and said whatever. He left and stood several feet away speaking with the crack dealer and the enforcers that were harassing us. The Guardian Angel that was with me started freaking out and said did you see his T-shirt? I was like no I didn't see his T-shirt. I don't care what his T-shirt said. Then he said that was a Hells Angel and the light went on.

I had spent many years on the streets and knew how a leader spoke. All the buff grown men that were harassing us jumped when he snapped his finger. Instantly I realized what he had meant and walked back over to him. I said if you're referring to gang business, we don't get involved in that. We just ask everyone if they do a gang hit not to do it in public so no innocent people get hurt.

He kind of smirked once I realized who he was and who he represented. Then the wheels started turning and I kept asking myself, what is he doing here with him? When I was young I used to ride a motorcycle. The chef where I worked rode a shovelhead and had a lot of friends who were bikers. One in particular was a member of the Gypsy Wheelers. I liked him. The Gypsy Wheelers were normal. Years later they patched over and became the Whiterock Hells Angels.

The chef that rode the shovelhead became a bit of a mentor and used to say to me don't believe what you hear about the Hells Angels. They're not into drugs or prostitution. They might smoke a little weed but they're into families and camping. This was before the Hells Angels were in Vancouver. His biker friends were like that but they weren't Hells Angels.

Years later I had bumped into him after he had returned from Sturgis. He said everyone there was very nice. They were like after you. I thought to myself, he had just ridden a rigid frame from Vancouver all the way to Sturgis, of course they're going to respect that. He did say it was a bit of a Sodom and Gomorah though.

Anyways, I was raised on the lie that the Hells Angels were not involved with drugs or prostitution. My mentor didn't lie to me, he just didn't know any actual members at the time. Just his biker friends he associated with.

So when I saw a Hells Angel enforcing for the crack dealers in Surrey Central I was like WTF is going on here. That's when I started looking into the Hells Angels criminal activity and I was completely blown away.

David Toner had left the Vancouver Guardian Angels and started a new group with his wife called FACT - Families Against Crime and Trauma. I kept in close contact with David and the two volunteer groups worked together on several projects.

David invited me to a rally at Bear Creek park his group hosted where they released doves in memory of loved ones lost to gang violence. Eileen Mohan and Steve Brown spoke and their grief moved me. Eileen was the mother of Chris Mohan who was one of the innocent victims in the Surrey Six murder. Steve was the brother in law of Ed Schellenberg who was the other innocent victim in the Surrey Six.

Steve mentioned how people always say someone was at the wrong place at the wrong time. Then he insisted his brother in law wasn't at the wrong place at the wrong time. He was at work doing what he was supposed to do, installing a gas fireplace. Steve carried a deep burden as he was supposed to be there that day.

Eileen's grief was equally moving. Her son was a great kid. He was on his way to play basketball. DK spotted him and dragged him in so he couldn't identify them. Chris was like I don't know these guys and they shot him anyways. That really upset the community.

Eileen's loss was heartfelt. She made a public appeal for a website to identify known gang members. She said in all these gang shootings we keep hearing the victims were known to the police. She said we were living next door to gang members and never knew. Had we known, her son would still be alive today.

I thought about what she said. I knew making that kind of website would be controversial. There would be legal challenges. There would be security issues. I mentioned the idea to Curtis and he said they had a guy in LA who did that. He said the gangs killed him. I thought with my background with

gangs in the Guardian Angels and my background in defending free speech on the Internet through trade Unions, I could do that web site.

I bumped into Eileen Mohan at the mall after the rally and introduced myself. I went out for coffee with her and Steve Brown to discuss this website idea. When I first sat down with her I said OK you're from India right? Yes she said, but you're Catholic and had a stunned look on my face. Yes she said then after seeking my confusion she blurted back, we did have Mother Teresa ya know.

I thought about what she said and replied yeah, I guess you did. In my mind that was predominately a humanitarian mission to serve the poor. It's just that I had grown up in Surrey and everyone I knew from India were Sikhs from the Punjab. My daughter had a friend from India visit who said wow, you have more Sikhs here in Surrey than we do in India.

So I started a website to identify known gang members and called it Gangsters out. I didn't think of it as outing gangsters at the time. I was thinking more like gangsters get out of our community like a crack down on crack campaign we'd do in the US with the Guardian Angels.

Nevertheless I did have a list of gang members saying this guy has been charged with this and that guy has been charged with that. I did get lots of legal threats. Steve Brown was also upset about bad decisions from Canadian court judges and wanted me to make a website at High Treason dot com. I thought I had been running so many domains as it was, it was easier if I just made a Judges Hall of Shame on the Gangsters out web site.

Later on I eventually did make a web site at Judicial Treason dot ca after a few insane court rulings, namely the Cowichan private land grab. Some people claimed you weren't allowed to criticize judges and said that was illegal. I said that claim was ridiculous. Judges are civil servants paid with tax dollars. They need to be accountable to the public.

David Toner had a retired judge on his board of directors named Wallace Craig who said not only was it lawful for the public to criticize bad judicial decisions, it was their civil duty.

Then there was Vern from Aldergrove who made huge billboards and T-Shirts saying Judges are the Problem. He claimed that the revolving door judicial system made judges accomplices to crime.

In my Judges Hall of Shame I spotlighted Peter Leask who was an idiot that let several Hells Angels off in very suspicious circumstances. One Nomad was caught red handed loading 52 kilos of cocaine from his storage locker onto a truck. The HA claimed it wasn't his and Peter Lask said the guy would have to have been f*cking stupid to have the locker registered in his name. So I made a meme of Peter Leask with Bugs Bunny ears on a Looney Tunes background and said he should be hanged for treason.

I had done a tour of the parliament buildings in Victoria where they talked about one famous BC judge back in the day named Sir Matthew Baillie Begbie who became known as the hanging judge because he sentenced so many people to be hanged. On my blog after citing Peter Leask I said we've gone from hanging judges to judges that should be hanged.

When Neil Hall wrote his book about Michael Plante and the Hells Angels he posted my meme and wrote what I said about Peter Leask. I certainly wasn't the only one concerned about some of his decisions.

Years later after police finally brought charges in the Surrey Six murder Eileen Mohan had filed a wrongful death civil lawsuit against the people who murdered her son. She had mentioned to me in one of the preliminary hearings she took one look at the judge and said where do I know him from? She said he looked familiar. Then right in the courtroom it dawned on her and she visualized the meme I had made with the Bugs Bunny ears on the Looney Tunes background. It was Peter Leask. He was presiding over her wrongful death suit. She cringed and thought oh I'm toast.

Eileen Mohan is a wonderful person. There is no way to dispute that. What happened to her son was a complete tragedy that crushed her. No two people agree on every political issue. As I continued my blog I started getting political. I kind of distanced myself from Eileen because I didn't want people to think she in any way agreed with or endorsed my political opinions. I was controversial, she was not. She was genuine.

All the politicians sucked up to her and looked for photo ops with her to promote their own agenda. Stephen Harper was one, Justin Trudeau was another. I hated them both. She was also friends with Dianne Watts. That became problematic.

When Dianne Watts was first elected mayor of Surrey we thought this was a dream come true. She had conservative values and was tough on crime. I met her at a rally in Surrey when I was helping David Toner with the Guardian Angels. She said her husband knew you guys. I thought to myself where have I heard that before. She said yeah he and Chris Taylor were with the Surrey group back in the /80's.

Chris Taylor? I said. That Brian Watts? That's your husband? Yeah I know him. He also volunteered with search and rescue. He taught us first aid. He and Chris were awesome. She invited me to her grand opening crime coalition press conference at City Hall where I bumped into Penny Priddy.

I had mentioned some of my trade union work in the past and she just raised her hand and said I'm here because I'm a mother. When it comes to crime, I'm more right wing than my political opponents. I respected that.

Dianne Watts had someone speak on the New York model which I was well familiar with. Under mayor Giuliani it was based on enforcement of the law. New York became safe and prosperous. She also talked about starting a web site that spotlighted high crime areas. It all sounded magnificent yet we were all deeply disappointed. Dianne Watts became a tax and spend Neo Con that wanted to toll every bridge under the sun to pay for her trips and junkets. Then she started suppressing crime stats instead of

spotlighting them. So I came out hard against her Neo Con agenda. Don't get me started on LRT. Surrey was Sky Train all the way. LRT on 104th Avenue would have been an infrastructure nightmare.

Eileen Mohan's son is buried in the same cemetery my parents are buried in. I bumped into her at the cemetery after all that and apologized for going after her friend. It wasn't personal. Eileen also had a great loyalty to the RCMP who she felt treated her very well.

She shared one experience where some gang members caught her in the parking lot of a mall alone and were harassing her for her activism. So she calmly called the police. When the RCMP showed up they were fairly aggressive with the gang members and said do you know who this woman is? Don't you ever harass her again. I get it. That was a good thing they did. Yet in my mind there were a lot of other bad things the RCMP did.

IHIT, tragically enough, screwed up the Surrey Six investigation in every way possible. Eileen was obviously disappointed in the sexual misconduct but she remained loyal to the RCMP because she felt they had treated her well. I get it. I respect that but in the end I supported forming a municipal police force over keeping the RCMP. The pros outweighed the cons.

Before I started the blog I was a letter carrier in Surrey for Canada Post. I distinctly remember walking past one house each day that was abandoned after a fire. There was large graffiti spray painted on the side of the house that said Hell Angels Pimp Surrey Girls. Every time I saw that I kept thinking about it and about the Hells Angel I met enforcing for the crack dealers in Surrey Central.

When I mentioned the graffiti on my blog someone claimed I was talking about things that could get me killed. Turns out that house was right around the corner from the Surrey House of Horrors. Then a troll accused me of being Anthon and I said who's Anthon? If you think I am him, maybe I should have a conversation with him. Turns out Anthon was one of the witnesses in the Surrey Six trial.

Then one day I came home from work and my daughter was in her room with tears in her eyes. I asked her what was wrong. She said someone was here looking for me. I sighed and said well we knew this day would come. She said he was a big guy with a leather jacket and kept saying where's Dennis? Then she said he had a notepad. It might not be bad. I thought yeah he's got a list. That is not good. She said I just missed him so I lost it. I went storming outside to find him. I see a car parked out front and I march up to the driver and said Are you looking for me?

The driver sitting in his car was startled and said no, who are you? I say in a loud voice I live over there and my daughter said someone is looking for me. Then I look up and see a big guy in a leather jacket walking towards me so I start marching up to him and say are you looking for me?

Then right before we collide I hesitate and think wait a minute, that guy looks like a cop. He instantly introduces himself as officer such and such and I laughed out loud. I thought you looked like a cop, I said. We thought this was a Hells Angels hit. He apologized for not introducing himself to my daughter and said he was with IHIT.

He said they were concerned that I had pictures of Anton posted on my website and they didn't want that to interfere with the investigation. I said well I certainly don't want to interfere with that investigation. I totally support Eileen Mohan and said I'd take the pictures down. Then I said it's a good thing you came to me and asked. I have a long history of doing battle with lawyers. Yeah? he said. Yeah, I replied.

Anthon was a good guy and I'm not going to say any more than I should. He used to be one of Jamie Bacon's bodyguards. Jamie asked Anthon to do the Surrey Six and Anthon said no. Anthon did confiscate the guns from the people they wanted to shoot so the team knew they guys they were going against were unarmed.

So the Surrey Six murder was the reason I started my blog. The Bacon brothers knew the guys in that condo. Jamie tried to tax them and they laughed in his face so he had to hire someone to kill them to save face. Anton wouldn't do it so he got DK, a subsequent body guard that took over after Anthon. Jamie Bacon couldn't go to the gym without a body guard. Spike, the president of the Haney chapter, used to bully him.

Then after the Surrey Six Jamie hired someone to kill DK only they missed. He was like WTF you missed. Then Jonathin tried to smooth things over and said it wasn't Jamie but it was and DK didn't believe him.

Before the Surrey Six, the Red Scorpions worked for the UN who were an anomaly. They were a gang of drug dealers who were independent of the Hells Angels. The Bacon brothers used to work for the UN but they broke off and started working with the Hells Angels because Jonathon was best friends with Larry Amero from the Whiterock chapter. After the Surrey Six the Red Scorpions started working for the Hells Angels so do the math.

When I first started my blog I said Larry Amero was behind the Surrey Six. Trolls said I was crazy. I stood firm on that claim. There was a big meeting the newspapers talked about between the Bacon Brothers and the Independent Soldiers at the Castle Fun Park in Abbotsford where they were all wearing kevlar. James Rach was there as he was with IS at the time. This was before the Surrey Six. They were plotting their corporation with each other after the Surrey Six.

James Raich was a Hells Angels associate. Originally the Independent Soldiers were an Indo Canadian gang completely separate from the Hells Angels. After the Loft Six shooting all the former members except for one were shot or died mysteriously in car accidents. The Hells Angels took over the Independent Soldiers just like they took over the Red Scorpions.

As I said, the UN were an anomaly. Under Clay's leadership they were organized and successfully stood up to the Hells Angels. A former Hells Angels associate from Maple Ridge told me about a big fight the UN had

with the Hell Angels in the beginning. I think Michale Plante, who eventually became a police informant, told the news about it.

My guy said the UN guys weren't really big, they were just really organized and there were so many of them. They all showed up with bluetooths and were in constant communication with each other. They fought and they held their own.

October 16th 2004, Clay Roueche went to Brandi's with K9 and a few other UN members. Gino was with Brandi at the time. The Hells Angels ran Brandi's as well as the Swedish Touch upstairs. K9 was big. He was a professional wrestler. They got in a fight with the Hells Angels and K9 knocked out Michale Plante. Google AI claims he sucker punched him but I think there was a lot more to it than that. The UN kicked their a*s and John Punko was pissed.

Punko said after that no one was allowed to do business with the UN. Yet Larry Amero did. Larry played them. Someone sent me a picture of Larry Amero with Sarah Trebble on New Years. You can identify Larry by the deathhead logo on the back of his hands. I call them deadheads. I remember seeing Larry at Costco in Langley once. I wasn't sure it was him until I saw the back of his hands. That was him.

Sarah Trebble was just how you say, a hang around. Jemma was his baby's mama but Larry was anything but faithful and Jema was quite the firecracker about it. Larry shared a car lease with Sarah. They do that. Put car leases in other girls' names to launder some of their money.

One day there was a shooting outside TBarz in Surrey which was a strip club owned by Randy Jones from the Whiterock chapter. It was named in a US indictment for being the hub of a cross border drug operation along with Randy and his brother Trevor but nothing ever came from it. Randy and Trevor were never extradited. Ask yourself why.

Anyways, in the shooting two UN guys targeted some Bacon Brother associates and Sarah Trebble was in the car. This is how Larry played them. Larry needed to show the UN he wasn't on the Bacon brothers side even though he clearly was. So he helps set up a couple associates, warns them in advance and says Sarah can ride with you during the hit. She was just a number. Larry never confronted the UN and always tried to do business with them even though he was supplying the Bacon brothers with guns and drugs to war with them.

The 2009 gang war was predominately between the Bacon brothers and the UN while Larry Amero played both sides. May 19 2008 the FBI rerouted Clay Roueche's plane to Mexico and arrested him in Texas. He's been in jail ever since. After Clay was arrested the Hells Angels started taking over UN lines. The Hells Angels are very good at what they do. They take over other drug trafficking networks through infiltration and betrayal or straight out war. They're also patient and persistent.

After Clay was gone, Larry Amero had a coming out party with Jonathon in Kelowna racing around like idiots on that ridiculous boat called Steroids and Silicone trying to pick fights with civilians. He finally announced his public support for the Bacon brothers which he had been doing all along. Larry was shot and Jonathon was killed August 14 2011.

Someone sent me a picture of the boat at the time. So Larry didn't publicly admit his support for the Bacon Brothers until three years after Clay had been arrested and the UN had been weakened sufficiently enough. Yet when Jonathon was killed he said Jonathon was his best friend. That doesn't happen overnight. Larry had been friends with Johnathon since High School. He supported them before the Surrey Six during the Castle Fun Park meeting.

So that's our starting point. My blog started with the Surrey Six and Larry Amero was the driving force behind the Surrey Six. Now jump over to Winnipeg, Manitoba. In 2010 the Winnipeg Hells Angels and the Zig Zag

crew were caught in a huge drug bust. The Zig Zag crew sold crack for the Hells Angels and they paid the Hells Angels protection money to sell drugs.

The bust was made possible because of a police informant named Agent 22. During that investigation Agent 22 came to Vancouver and a Hells Angel associate named Eric Sandberg told the agent that he could get him any gun he wanted and that they, meaning the Hells Angels, were ready to wipe out all the competition in Surrey. That was in 2009 after Clay was arrested in 2008. August 2011 Larry Amero comes out of the closet and gets shot alongside his bff Jonathon Bacon.

Right before Larry Amero was shot in Kelowna I was told that he and Jonathon Bacon attended Nabil Alkhalil's wedding in Ottawa. Nabil was Robby Alkhalil's brother. After Larry was shot I made a blog post in 2012 asking if Larry was back in Montreal as my sources claimed. I met the person in charge of the OMGU in BC before it was disbanded who was rock solid and he said that claim matched their intel on Larry.

That's why he wanted to meet me. He wanted to find out who I was. At the time I was anonymous. I went by the username Agent K from the Movie Men in Black. I also went by Tom Jones as a spoof because Tommy Lee Jones played Agent K in the movie. When we met he asked me my real name but I wouldn't tell him. He was persistent and was all how can we develop a relationship of trust if I don't know your real name.

I was like we don't have to develop a relationship of trust. We don't have to do anything and I don't have to tell you my name. Finally I caved in and told him. I went to the computer and looked up a news clipping when I took over the Vancouver Guardian Angels after David Toner had resigned.

There was a huge gang shoot out at Dover Park in Richmond right in the middle of a residential complex so I put up white balloons around the park and held a press conference calling for a cease fire. The article had my name and picture. I show it to him and he says how do I know that's you? I'm like look at the name and look at the picture. That's me.

It's really too bad they disbanded the OMGU in BC. That guy was solid. Anyways Larry Amero was arrested in a huge drug bust in Montreal November 2012. It was a big cross border cocaine ring and included large quantities of crystal meth precursors to Australia.

He got off on that one over trial delays but something significant happened during that trial. Two of his co accused were brutally murdered. One in Greece the other in Colombia. Thimoleon Psiharis was beaten to death and dropped in acid in Greece by Damion Ryan and Robby Alkhalik. That's how Damion Ryan got his filthy few patch. Frédéric Lavoie was dismembered in Colombia by Steven Skinner who was a Hells Angels associate.

Skinner was sentenced to 11 years for manslaughter in the murder of Stacey Adams in Nova Scotia and made full parole in 2023. He was accused of the Lavoie murder in Colombia but never charged.

When I saw that I said WTF? Is Larry Amero delusional? Killing Quebec members? Who the f*ck does he think he is? That bust even made the ridiculous claim that Shane Maloney was a high ranking member of the West End gang. GMAFB. Shane Baloney was a loser from Burnaby who would rip people off. He was the illegitimate son of a waitress. They called him wheels because he was in a wheelchair. Conflicting stories as to why.

Then it all made sense. Walter Stadnick. The 5' 4" Anglophone from Hamilton. Jerry Langton wrote a book about him called Fallen Angel: The Unlikely Rise of Walter Stadnick and the Canadian Hells Angels.

Stadnick became the National President of the Hells Angels and made Mom Boucher his general. That's how he became National President. He had the support of Mom Boucher and Quebec. Quebec were the sh*t when it came to the Hells Angels in Canada. They were established there first and made quite an impression. The Hells Angels in Ontario were always the village idiots. In BC they were the money makers and businessmen but in Quebec they were the real deal. They waged a war with the Rock

Machine for ten years but that's a separate matter. As is the Walter Standick connection to Larry Amero.

Suffice it to say that Larry Amero got in well over his head. He survived that bust over trial delays but was arrested again in Ottawa January 2018 for the murder of Sandip Duhre at the Sheraton Wall Centre in Vancouver and conspiracy to commit the murder of Sukhveer Dhak in Surrey. Those charges stuck. However, in August 2012 the police searched the penthouse he shared with Robby Alkhalil in Montreal and seized their cell phones. That led to his Vancouver conspiracy to commit murder conviction.

There's a whole lot of stuff going on all over the place here and I'll try not to bounce around too much. Again Larry Amero was behind the Surrey Six. He was behind the Bacon Brothers in their 2009 war with the UN in Surrey and he was involved with a whole lot of shady sh*t in Montreal along with Walter Standick. He was also involved with a whole lot of drug trafficking in Ontario through the Alkhalils.

The point I'd like to make now is that Eric Sandberg told Agent 22 the Hell Angels were ready to take over the Surrey drug trade in 2009. After Clay Roueche's plane was diverted and he was arrested in 2008, the UN were pushed to the side as all the leaders were either in jail or in exile in other countries. Conor D'Monte was recently arrested in Puerto Rico but he was no longer involved. Other leaders in other countries are not involved in the Vancouver drug trade. That's important because the Five Eyes and the fake news are pushing an alternative narrative.

The Edmonton Angels, Redd Alert and the Brothers Keepers

The Edmonton Hells Angels run and ran Redd Alert which is a First Nations gang that sells drugs for the Hells Angels. Someone posted the Redd Alert Bible online which is a rule book of sorts that conforms their allegiance to the Hells Angels. Which brings us back to Pat Fogarty and Manny Mann.

In August 2011 when he was in charge of the BC CFSEU Pat Fogerty told the Kelowna Daily Courier that "There is no Wolf Pack. I don't know where people get that type of information. Probably the real truth is they were holidaying up there." He was referring to when Larry Amero and Jonathon Bacon were shot in Kelowna. That was somewhat astounding.

The term Wolf Pack was first used by Post Media news who claimed it was a new alliance between the Hells Angels, the Independent Soldiers and the Bacon Brothers. I argued it was not a new association because James Riach was with them and slipped out the back door of the vehicle during the shooting. That's why I referred to him as the gingerbread man.

James Rich and the Independent Soldiers met with the Bacon brothers at the Castle Fun park meeting in kevlar before the Surrey Six. Jonathan Bacon was Larry Amero's best friend. Larry Amero was working with him before the Surrey Six. Wolf Pack 81 was Larry Amero's gamer tag on X Box live. I kid you not. So it was astounding that the head of the BC CFSEU would make such an absolutely ridiculous statement to the press.

That's why I made a blog post at the time asking which side was he on? He went on to claim "The Hells Angels chapter has almost dismantled now. They don't even have club status any more. Our biggest fear here in our province is actually the ones that aren't named."

That was absurd. Here we had the head of the BC CFSEU running interference for the BC Hells Angels in the press. He was referring to the Kelowna chapter of the Hells Angels. At the time I had been blogging about David Giles the vice president of the Kelowna chapter referring to him as Skealtor because he kept getting implicated in large drug busts but the charges never stuck.

So right when the Kelowna Hells Angels were at their peak, Pat Fogarty claimed they weren't the problem, they barely have a chapter in Kelowna. It's the other guys we have to worry about. That was August 2011 right after Larry Amero and Jonathan Bacon were shot.

In 2012 I launched the Kelowna Summer Jam. It was a spoof from a Young Jeezy song called Soul Survivor which said "If you get jammed up, don't mention my name." I said the heat is going to be on this summer in Kelowna and put up posters outside the Hells Angels clubhouse asking for information about the murders of Britney Irving, Geoff Meisner and Dain Phillips. Unbeknown to me, the OMGU also did an undercover operation in Kelowna that summer targeting David Giles and the Kelowna Hells Angels.

Their under cover operation was very successful. They finally took down David Giles in a large drug bust as well as an associate named Johnny Newcome who was reVINing stolen vehicles for the Hells Angels. August 2011 Pat Fogerty said the Hells Angels in Kelowna aren't a problem and in August 2012 the OMGU proved him wrong. Giles was convicted.

The OMGU did such a great job the BC Liberals disbanded them. The BC CFSEU has been compromised ever since. In April 2021 Manny Mann, the new head of the BC CFSEU said the same thing. Manny claimed "there are now more gangs in B.C. and more rivalries than there were 11 years ago at the height of the well-documented gang war."

"At that time, the conflict primarily involved the Red Scorpions versus the United Nations, with some involvement by other groups such as the Independent Soldiers and Wolfpack. More recently, new groups such as the Brothers Keepers and the Red Scorpions-linked Kang group" which means more violence. He failed to mention every single one of those groups except for the Kang faction were run by the Hells Angels. That's an important fact to omit. The HAs ended up wiping out that Kang faction.

After the Surrey Six the Hells Angels took over the leadership of the Red scorpions after they had already taken over the leadership of the Independent Soldiers. Years later Gary Kang started a faction within the Red Scorpions called BIBO trying to break free of the Hells Angels but they too were exterminated. So all those different names means one group - the

Hells Angels. In another post I said there might well be 50 ways to leave a lover but there are 180 ways to say Hells Angels.

So back to the Edmonton Hells Angels and Redd Alert. Redd Alert is another name of another gang but they also work for the Hells Angels. Having all these different groups creates plausible deniability. It's not us, it's them. But they all work for you. At one time when the UN were at their peak, they took over the drug dealers in the DTES from the Hells Angels.

Shane Knox ran the Balmoral. I have a huge amount of respect for that guy. He has since left the life and volunteers with Kal Dosanjh and Stan Price over at Kid's Play. Shane grew up in the Balmoral with his mother when he was a kid. That was hard core. When Shane was in Calgary some IS guys came after him with a Mac10. He gets off the elevator, runs up to the guy with the Mac10, which is fully automatic, rips the magazine out, pistol whips him with it then runs out of the lobby while the IS mob chase him. It was all caught on camera and played in court. That was hard core.

Stan Price was Redd Alert and left the life on good terms. He does speaking engagements to kids at school with Kal Dosanjh who does great work with his volunteer group called Kids Play.

Redd Alert took back all the drug dealers in the DTES from the UN and brought them back to the Hells Angels. Then the DTES was given to the Wolf Pack and Edmonton was given Surrey. In May 2017 the Edmonton Angels killed Janice Nicole Bryant, who was Glen Nelson's wife. Glen Nelson led the Redd Alert in taking back all the drug dealers in the DTES from the UN. So he was the man. They gave that territory to the Wolf Pack, killed his wife and said suck it up. I kid you not. I was in the drum circle at Janice's memorial.

Obviously, Redd Alert were not happy about handing over that territory after they won it back. That's when the Wolf Pack created RK, Redd Alert Killers. They used that name to make it sound like FK in Calgary to make people think they were a rival. FOB or Fresh off the Boat were a Calgary gang that

sold drugs for the Hells Angels through the BC Independent Soldiers who have since been replaced by the Wolf Pack.

FK, FOB Killers were a rival run by the UN. The Wolf Pack created RK to make it look like they were run by the UN but they weren't. They were also supplied by the Wolf Pack. That was another con tied to Larry Amero and Damion Ryan who run the Wolf Pack for the Hells Angels.

After the Wolf Pack were given the DTES and the Edmonton Angels were given Surrey, the Edmonton Angels created BK, the Brother's Keepers. This was an Indo Canadian gang that sold drugs for the Edmonton chapter. They had some internal power struggles, some didn't want to work for the HAs but they were all killed. BK worked exclusively for the HAs.

So again, all these different names really mean one thing, the HAs. Then we had Suminder Grewal aka Ali. Ali was a full patch Hells Angel. He was Indo Canadian and belonged to the new Hardside chapter in Surrey. They ran a group called the Street Reapers in Fort Langley.

The Hardside chapter has been recently disbanded so that leaves me wondering about who owns the Street Reapers. I saw a harley parked at the grocery store in Surrey recently with a Street Reaper logo on it. I'm not sure if they've been disbanded as well.

My point is Ali was close to the Brothers Keepers. They were Indo Canadian and so was he. They respected him. I heard one story about some BK guys crashing a wedding in Surrey and the bride said do you know who I am? Turns out she was related to Ali. When the BK guys found that out they apologized, returned the stolen items and left.

Ali did all the work with the Brothers Keepers and wanted a piece of the pie but Edmonton said no. They just gave up the DTES. They weren't going to share Surrey. So they killed him. They killed their own guy. BK wouldn't do it because they respected Ali so the Edmonton chapter got some guys from Edmonton who owed them money to do it.

As you can imagine, that created a bit of friction within BK. Just like killing Glen Nelson's wife did for Redd Alert. So the Edmonton Angels brought in some Somalians from Toronto and made Lil Man or Certi2x the connection between BK and the Driftwood Crips. Again another name of another group who work for the Hells Angels. Around the same time the Wolf Pack brought in some Jamaicans from Montreal into the DTES called Zone 43. Another name of another group that work for the Hells Angels.

The Hells Angels killed Gary Kang because he was leading a faction within the Red Scorpions called BIBO that were trying to break free of the Hells Angels. So BK and BIBO went to war and after Jamie Bacon flipped and started cooperating with the police, Kyle Latimer and Lolo Laanski betrayed BIBO and BIBO was finished. As a result the Hells Angels reimaged complete control of the Red Scorpions along with everyone else.

Right after Gary Kang was murdered Anees Mohamed was killed. He sold drugs for Damion Ryan in the DTES. They tried to make it look like the UN killed him when it was really Certi2x. Damion Ryan had him kill his own guy for flexing. Then he tried to make it look like he was killed by a rival.

Then you guessed it. Damion Ryan had Certi2x killed by his own crew in Surrey. A guy on Tik Tok called Vancouver Royalty said it well. He made a video about Certi2x's murder and said "You kids aren't ready for the street life because on the streets betrayal is certainty and your own crew will gun you down in your own crib, burn that b*tch down, take all your jewelry and cash and just like that, they'll never even remember your a*s again. You'll just turn into dog food."

"You thought the gang was going to be loyal to you but once the order comes in from the higher ups, those orders must be carried out because if the order was given to you and you don't want to carry it out because that's your man, that's your friend, that's your this and that, guess what? You're gonna be next up. They're gonna come take your a*s out now. So you

know that's how the streets go just like they did Gavin Grewal at his own penthouse. Just like Certi2x." He nailed it.

They're going to ask you to kill your own guy and if you don't they're going to kill you. That's the way they roll in Van City. No L&R just greed and betrayal. So leave the life. Don't walk away mad, just walk away.

Neil Cantrill was an Edmonton Hells Angel that ran a grow in BC through Richard Houle. After 12 years Richard eventually said he was ready to retire and wanted out. A year and a half later Neil and his son along with another Edmonton Hells Angel named Robert Lowry kidnapped Richard, brutally beat him and told him he'd have to sign over his house if he wanted out. That's how these guys do business.

Then we had the political assassinations of Hardeep Singh Nijjar and Ripudaman Malik which the government of India contracted out to the Brothers Keepers out of Edmonton. That's when the extortion cases in Surrey and Brampton got out of control, all linking back to the Edmonton Angels. Now they've flipped the script and claim it's a gang from India that works for India's intelligence agency. Bullsh*t. It's India's Intelligence agency contracting it out to BK through CSIS. That's my take on it now.

We know that the murder of Hardeep Singh Nijjar in Surrey was tied to the murder attempt of Nikhil Gupta in New York. The murder attempt of Nikhil Gupta was a sting orchestrated by US Intelligence. Only they stopped that before it happened. Kind of like the FBI foil FBI terrorist plot kind of thing.

Since we know that the murder of Hardeep Singh Nijjar in Surrey was tied to the murder attempt of Nikhil Gupta in New York, it would be logical to assume that was also a sting orchestrated by Canadian Intelligence. Only they failed to stop it before it happened just like Air India.

So how has the Vancouver gang war changed from 2009 when I started my blog after the Surrey Six? We've gone from Hells Angels drug trafficking to

Intelligence Agencies profiting from out of control extortion. Which ties us directly to the William Majcher and the Cameron Ortis case.

The New York Model - How New York has changed

Before we talk about the Bill Majcher case let's talk about how New York, the town I loved so well, has changed over the years. In the /80's New York was known for crime and violence. It was hard core.

That's when I showed up to do volunteer work with the Guardian Angels in the subways. Before I went to New York I had watched the movie Warriors a million times thinking that's what to expect. When I arrived, that's not what I found. In the /70's when Curtis first started the Guardian Angels New York was known for gangs fighting over turf.

When I was young I read the book Run Baby Run about Nicky Cruse. That story took place in the late /50's early /60's. The movie Gangs of New York took place during the American civil war from 1862 -1863. So New York has a long history of gangs. In fact they invented them.

LA however, perfected them. When I arrived in New York most of the gangs were gone but they thrived in LA. I was told, when I was there in the /80's that the New York cops took a very aggressive response to the gangs. If they were wearing patches or gang colours they would line them up, search them down and harass them. Wearing gang colours made you a heat bag. Eventually the gangs weren't as common. There were a few but nothing like it was in the /60's or /70's.

Keep in mind, New York cops were aggressive. As I've said on my blog, when I was in New York we were broke kids from the hood volunteering our time to patrol the subways. Since we were working for free, we'd sometimes jump the turnstiles. We wouldn't literally jump them unless there was a big fight we had to break up. We'd simply push the turnstile forward half a turn and slip through.

One time I did this and an undercover cop caught me and yelled at me. I looked over my shoulder and thought it's just a ticket so who cares. Then afterward the guy that was with me from Queens said WTF was that. I'm like what do you mean we always do that. He's like, no I mean you were going to run I saw you. I was like yeah but I thought it was just a ticket so who cares? Then he starts freaking out and says you don't run from a New York cop? I was like why not? He's like because they will shoot your a*s dead. I was like ya? I guess it's a good thing I didn't run.

My point is, New York cops adapted a very aggressive response to the gangs and by the time I showed up in the /80's the gangs of New York were nothing compared to what they used to be. The crime and violence was certainly off the hook but the gang presence had changed.

At the same time gangs in LA thrived because instead of patches or logos they just wore color bandanas. When I was in New York Lisa Evers was briefing me for my trip to London because she was the National Director and she oversaw international expansion at the time. When she found out I was part Irish she made a point of commenting to me that the Irish gangs were very big in New York at one time. Not then but historically.

They certainly were. Hells Kitchen was notorious for that but it wasn't when I was there. That time had passed. Just like the West End gang in Montreal. That was past history.

Many years after I had returned from New York I watched a documentary called the Seven Five about Michael Dowd. Michael Dowd was a dirty cop from the 75th precinct in Brooklyn who made a tell all documentary after he got out of prison. The guy was a POS.

There was a grocery store in Brooklyn that sold drugs by the kilo in the back. Every time the police would try to raid them Michael Dowd would warn them first. He was very much on the take and would give drug dealers police escorts to move cash. He bragged about it in the documentary.

After he was busted there was a public inquiry. When they cleaned up police corruption that paved the way for Giuliani to come in and create the New York model during the US crack epidemic which successfully transformed New York into a safe and prosperous city.

Until Bill de Blasio flushed it all down the toilet and turn New York into a Liberal sh*t hole. That broke my heart. After visiting New York we launched a Crack Down on Crack campaign in South Seattle.

Chuck Pillon was a good cop who contacted us at the time. He said he was putting pressure on the crack dealers in Rainier Beach so they transferred him and put him behind a desk. That looked really suspicious. Then we saw another really good cop come in and start putting pressure on the crack dealers. Called himself the Sheriff. He was hilarious. Then they transferred him too. Once was suspicious, twice was a pattern.

That reflected police corruption at a higher level from the top down. That's what we see in BC. It started with the rat out your rivals program. They paid drug dealers to rat out their rivals and in exchange let them sell drugs. Until there were no more rivals because their rivals didn't embrace the same program as eagerly as they did. Then we had Gang Task force blaming fake rivals for HA hits. That's where we are now.

That big cocaine bust in South Korea tied to the Rock Machine with the UN logo stamped on it was completely manufactured. Do I actually believe that? Yes I do. I have many reasons but for right now I'm just going to call it the way I see it. Just like the extortions in Surrey and Brampton. Those are tied directly to CSIS and the Five Eyes.

The Quebec Biker War

The Hells Angels first established their definitive presence in Quebec under Mom Boucher but Mom Boucher certainly wasn't a founding member. He simply rose to the top and established a legendary legacy.

The first Hells Angels chapter in Canada was established in Montreal 1977. In contrast, the first Hells Angels chapter in BC wasn't until 1983 when Rainbow Ricky's Satan's Angels patched over in Vancouver and the Gypsy Wheelers patched over in Whiterock. The first Hells Angels chapter in Nova Scotia was in 1984 when David Giles and the 13th Tribe patched over.

David Giles spent a considerable amount of time in Quebec during the biker war. There is a screen shot from a History channel documentary of Giles standing beside Mom Boucher when he got out of prison. David Giles' first stolen motorcycle was from the Lennoxville massacre.

Wiretaps played in court revealed that Hells Angels' Luc Michaud and Robert Richard promised Halifax bikers their split of motorcycles and parts in the weeks after the murder of the Laval chapter.

One wiretap on April 7 1985, Michaud calls the Halifax chapter and jokes with Ronald MacDonald, David Giles and Robert Milton. Richard tells Giles not to make plans for his motorcycle because a second truckload of goods is on its way. "There's a surprise for you in the truck. You'll flip out." They joke about murdering their brothers and stealing their property then sign off with "Happy Easter, I love you." Gag me with a spoon.

Mike Christiansen and David Giles came out West and joined the East Vancouver chapter then became founding members of the Kelowna chapter.

When we examine the history of the biker war in Quebec we need to start with three names, Mom Boucher, Biff Hamel and Salvatore Cazzetta. Later we'll add Wolodumir Stadnick to make the web of deception complete.

As I said Mom Boucher wasn't a founding member of the Hells Angels in Quebec but he certainly rose to the top. Mom Boucher started off as a petty thief who served a prison sentence for armed rape. He and Salvatore Cazzetta formed a MC called the SS. Biff Hamel was with that SS MC.

Mom Boucher and Biff Hamel wanted to become Hells Angels. Biff was a prospect for the Laval chapter and was present at the 1985 Lennoxville massacre where five members of the Laval chapter were killed by fellow Hells Angels. Seemingly Salvatore said WTF and didn't want anything to do with that. I say seemingly because there was a lot more to it than that including a very sinister agenda that didn't play out until Mom Boucher finally went to prison.

Salvatore didn't join the Hells Angels he started the Rock Machine who became Hells Angels rivals but he remained friends with Mom Boucher because they had a plan and an agreement. Biff Hamel and Mom Boucher joined the Hells Angels. Biff Hamel got his patch October 5, 1986 and Mom Boucher got his patch May 1, 1987 after getting out of prison for armed rape.

Mom Boucher and Biff Hamel didn't have a problem with the Lennoxville massacre like we thought Salvatore did. They both saw it as an opportunity for their own advancement. Biff was there when they killed his sponsors. Instead of saying WTF you just killed my brothers they said to him do you want to take their place? Hell yeah he said.

It takes a certain kind of person to do that and this is the type of person these people were. Biff Hamel and Mom Boucher earned their patch through the Death Riders' betrayal also in Laval. The Death Riders were formed in the early 1980's and ran drug and prostitution networks in the area.

"The takeover became absolute on May 4, 1987 when the President of the Death Riders, Martin Huneault, was shot to death in a Laval bar. No one was ever arrested for the murder, but just hours after Huneault's funeral,

Death Riders Mario Martin and André Richard were seen meeting with Hells Angels Maurice Mom Boucher and Normand Biff Hamel. Boucher and Hamel received their colours after the incident and Huneault's murder allowed the Hells to completely take over drug trafficking in Laval and the lower Laurentians area.”

Notice the pattern. They shot the president and two of his own guys seized the opportunity to advance in the club. This pattern has been repeated multiple times in BC. So Hamel and Boucher got their patch for taking over the Death Riders and securing control of their drug and prostitution network in Laval after the Laval Hells Angels were killed in the Lennoxville massacre. Boucher was in. He got his foot in the door. So how did he rise to the top? Wait ‘till I tell ye. That’s where Wolodumir Stadnick comes in.

Wolodumir ‘Walter’ Stadnick became a full-patch member of the Hells Angels on May 26, 1982. He joined the Montreal South ‘mother chapter’ despite not speaking French, later becoming a key figure in the club's expansion across Canada and acting as the national president.

So Wally joined in /82 and the Lennoxville massacre was in /85. He joined the Montreal South chapter but he didn’t speak French. He was an Anglophone from Hamilton. So the question remains, how on earth did a 5’ 4” Anglophone weasel from Ontario become the National President of the Hells Angels when Quebec had such a powerful and credible reputation? Through treachery and deceit.

Jerry Langton wrote a book called *Fallen Angel: The Unlikely Rise of Walter Stadnick and the Canadian Hells Angels*. Stadnick took Boucher under his wing and made him his Lieutenant. He put Boucher in charge of Quebec so he could get Quebec’s support to become National President.

The pattern of treachery and betrayal in the Lennoxville massacre and the Death Riders take over repeated itself to help Wally rise to the top and stay on top and this my friend ties in with Salvatore Cazzetta.

When I started my blog it went viral. An author from Montreal who had studied and written about the Hells Angels came out to Vancouver to meet with me. We had dinner at the Old Spaghetti Factory in Gastown. He shared with me many experiences he had while investigating the Hells Angels in Quebec as well as the Rock Machine.

He shared one experience he had trying to save a young girl he met on the street. She had been dragged into drugs and prostitution. He found her in a nasty whore house where she was chained to a bed, had a bucket to use for the bathroom and was paid in crack cocaine. That was human trafficking and it was deplorable.

He also shared a conspiracy theory he was told by members of the Rock Machine. They told him that during the Quebec Biker war, the Rock Machine were secretly working with Stadnick and Boucher. Their death squad wasn't just killing any Hells Angels, they were specifically targeting Hells Angels who were a threat to Stadnick and Boucher's leadership.

Although that was entirely plausible, at the time it seemed a bit far fetched. Until Mom Boucher went to prison and all the leaders of the Rock Machine crossed over and became leaders in the Hells Angels to secure Boucher's standing while he was in prison. When that happened I was astounded. All of a sudden that crazy conspiracy theory had a whole lot of merit.

Biff Hammel was Mom Boucher's associate from the SS and joined the Hells Angels right before Mom Boucher did. After Boucher got his patch, he became a founding member of the Quebec Nomads along with Biff Hammel and Wolodumir "Walter" Stadnick, also known as "Nurget",

Remember, Biff Hammel and Mom Boucher were responsible for the Death Riders betrayal and take over. On 17 April 2000, Hamel was gunned down when attempting to flee from Rock Machine assassins in a Laval parking lot. Following Hamel's death, the Death Riders which he supervised merged with the Hells Angels' main puppet club, the Rockers which was run by Mom Boucher. Greg Wooley was a member of the Rockers. He

became Mom Boucher's body guard and Boucher made Wooley president of the Rockers.

Mom Boucher and Greg Wooley were close to the Rizzutos. Through Greg Wooley, Mom Boucher supplied all the Crips in Montreal with drugs. So do the math. Biff Hamel was Mom Boucher's "friend" from the SS but Biff Hamel got his Hells Angels patch before Boucher because Boucher served a prison sentence for armed rape.

Biff Hamel was in charge of the Death Riders until he was killed by the Rock Machine. After that the Death Riders merged with the Rockers and fell under the jurisdiction of Mom Boucher. So did the Rock Machine kill Biff Hamel or did Mom Boucher and Stadnick? You tell me. If Salvatore was still friends with Mom Boucher and if the Rock Machine were killing political rivals to Boucher and Stadnick this would clearly appear to be one of those cases because Mom Boucher financially profited from Biff Hamel's murder.

So Biff Hamel's murder would clearly support the theory that the Rock Machine were killing Mom Boucher's political rivals within the Hells Angels. So would the fact that Salvatore and all the leaders of the Rock Machine patched over to become leaders in the Hells Angels when Mom Boucher went to prison.

Another motive for the formation of the Rock Machine's Death Squad was the simple fact that not all Hells Angels members profit from the sale of drugs. Only leaders do. Usually it's one guy and one associate in charge of a puppet club under the direction of the local president. By killing political rivals within the Hells Angels, Mom Boucher and Salvatore were able to secure leadership positions over drug lines while Stadnick rose to the top as National President.

I don't like Stadnick and I'll tell you why. He's a political, backstabbing, self serving weasel. How do I know? Because I saw him in action when he first got out of prison.

When I started my blog I found out about a support group in Scandinavia called TBM Fresh Start. It was about helping gang members leave the life. TBM was an abbreviation for the Danish word for gangs. They were well established in Denmark, Norway and Sweden. So I linked to them and I linked to their blog.

They were very organized. They had safe houses set up to help people leave gangs. The founder and international spokesman Michael Green was the real deal. He was a former Bandido and a former Hells Angel. Good speaker, good head on his shoulders, good guy doing good work. I totally supported him.

They started a facebook group that was gaining traction in Canada and I considered joining their organization. It made sense that was a positive direction my blog could go in. Helping people leave the life. Starting that in Canada was something I supported but like with David Toner and the Guardian Angels, I didn't want to do it all. I didn't mind helping out but I didn't want to be in charge.

So there was this buff guy, former Rack Machine, who was willing to help with a Canadian chapter of TBM. I took one look at him and said yup. That's the guy. People on the West Coast would respect him. I was willing to help him start a Canadian chapter. Then came Wally the Weasel.

TBM made this facebook group and everyone shared administration roles. There were no power struggles. Until this new guy got involved. His username was Tony but it was obviously Standick. He showed up right when Stadnick got out of prison.

He was an Anglophone living in Montreal who kept bragging about his friendship with Mom Boucher. He kept going on and on about my friend Mom Boucher and we were like dude, stfu. Nobody cares if you were friends with Mom Boucher. They guy served jail time for armed rape.

He kept using that as leverage to portray himself as someone bigger than what he really was. Total short man syndrome. Kind of like Ben Shapiro. Then he started kissing Michael Green's a*s and would trash anyone from the Rock Machine who joined the support group.

I was like OK this is a support group for people who have left the life. We need to set old beefs aside. I could see exactly what was going on and I didn't like it. Micheal Green was a great guy but this weasel trying to sway him was trouble. Then when this buff guy from the RM said he was willing to help out Standick launched a defamation campaign against him. When I said hold the door he answered me through the administrators profile we all had access to to make it look like he had authority over me.

I was like WTF? I have access to that administrator profile just like everyone else. No one else uses that profile in such a slimy way. Only him. I had had enough and outed him. Michael Green claimed it wasn't Stadnick it was someone else but it couldn't have been anyone else. Anglophone living in Montreal who had a long history with Mom Boucher. Then there was the sleazy political back stabbing MO. That was him.

I think Michael said it wasn't Stadnick because Stadnick was on probation and wasn't supposed to use the internet and if I outed him, he would get nailed for breach of probation. I didn't care, the guy was a d*ck being a weasel. As long as he was involved I was out so I shut down my Facebook and gave up on that project. My point is, Stadnick is still causing sh*t and it's tied to the betrayal of the Rizzutos in Quebec and tied to Larry Amero.

So back to the Quebec biker war. That author from Montreal told me Rock Machine guys said they were working with Stadnick and Boucher to kill Hells Angels who were rivals to their leadership within the organization. When all the leaders of the Rock Machine crossed over and became leaders in the Hells Angels that all of a sudden became believable.

The Rock Machine tried to kill Louis "Mélou" Roy who was second-in-command of the Hells Angels' Nomads chapter, on 23 August

1997. Remember, Boucher and Stadnick were also members of that chapter. Danny Kane claimed that Boucher and Vito Rizzuto set the price of cocaine to be \$50,000 a kilo and anyone who sold it for less than that was to be killed. Louis "Mélou" Roy, who ran the drugs in Trois-Rivières sold it for less than that which infuriated them.

Andrea "Andrew" Scoppa claimed that Vito made a secret deal with Boucher to kill Roy. According to Scoppa, Roy went to Boucher's party and then went to the meat factory to meet Matticks where he was put through a meat grinder. So again we have yet another internal murder of a political rival within the Hells Angels that helped Stadnick and Boucher's quest.

This fake biker war in Quebec was orchestrated by Stadnick to help him and Boucher rise to the top and stay on top within the Hells Angels. That same pattern of betrayal in the Lennoxville massacre and the Death Riders take over repeated itself over and over again. L&R what?

Let's remember one thing. Notwithstanding Stadnick's weasel politics, Mom Boucher had gained a huge amount of credibility in Quebec. As long as Stadnick had Boucher on his team, Stadnick's leadership wasn't challenged. Let's also remember that Boucher was also tight with the Rizzuttos. Vito and Boucher ran the show. Remember that.

Operation SharQc was a massive Quebec police raid in 2009 targeting the Hells Angels, resulting in 156 arrests, including most of the gang's Quebec members, for conspiracy to commit murder and drug trafficking. After Operation SharQc the Ontario Village Idiots slid over to take control. They sent Jeff Lynds to Halifax who screwed things up royally.

Randy Mersereau was a former member of the Halifax Hells Angels who disappeared during a biker gang war. He was the target of a failed bombing at his car dealership in Bible Hill, and had not been seen since Oct. 31, 1999. His brother, Kirk Mersereau, and his brother's wife, Nancy Christensen, were found dead in their home in Centre Burlington, Hants

County, in September 2000. It was reported that Randy had left the Hells Angels but continued to sell drugs making him a rival.

Jeff Lynds ended up cooperating with the police and admitted to shooting Randy Mersereau then ratted out his nephew Curtis and Les Greenwood for the murder of Randy's brother and sister in law which he ordered.

Jeff Lynds said he lured Mersereau to the home, shot Randy five times with a hand gun provided by the Hells Angels who ordered the hit. He then claims Curtis Lynds and Dean Whynott took the body to a nearby field and buried it.

So get this, Jeff Lynds was a member of the Hells Angels, he ordered the murder of Randy's brother and sister in law and rats out the people he hired to do the murder. Then he mysteriously died in prison by suicide. Locals believe the police faked his death and he went into witness protection.

Les Greenwood's co accused in the murder of Randy's brother and sister in law was Michael Lawrence who pleaded guilty in January 2012 to first-degree murder in the deaths of Mersereau and Christensen. Later that same year, Leslie Douglas Greenwood was also found guilty of two counts of first-degree murder.

Jeff Lynds' nephew Curtis pleaded guilty to his involvement in that murder. He didn't pull the trigger but he set it up for his uncle Jeff who was a member. According to an agreed statement of facts, Lawrence owed Lynds \$28,600, after a botched robbery in 2000. On Sept. 9, Curtis Lynds picked Lawrence up and told him he had another job for him instead of a robbery. He told Lawrence killing Mersereau would cover his debt.

Court documents said Lawrence and Greenwood drove to Mersereau and Christensen's home in a stolen pickup truck. Greenwood went into the house and shot the couple in the stomach.

Lawrence then went into the house to make sure they were dead by shooting them both at close range in the head. He returned to Lynds' home and was assured his debt was paid.

Jeffrey Lynds - once the highest-ranking Hells Angels member in Nova Scotia - died in prison in January 2012 while waiting to be tried on first-degree murder charges. Things that make ya go hmmm...

Les Greenwood, who had twice been convicted of 1st-degree murder of Kirk Murray and Antonio Onesi in Montreal had both convictions thrown out on appeal and finally copped a plea of manslaughter. Greenwood was the getaway driver for the double murder in Montreal.

Robert William Simpson and his younger brother Shawn both from Nova Scotia were the shooters. Robert Simpson had been working as a bodyguard for Jeffrey Lynds when he was living in Nova Scotia. Simpson said Lynds was a full-patch member of the Hells Angels Nomad chapter based in Ontario when he agreed to work as his bodyguard.

Shortly after his arrest for the double-murder, Simpson decided to become a co-operating witness for the prosecution. Simpson made it clear early on in his testimony that he had murdered at least seven people before becoming a prosecution witness.

Initially, Simpson told the jury, his work with Lynds involved establishing the gang's drug trafficking presence in Nova Scotia, by selling drugs purchased in Montreal. He told the court that in late 2009 there weren't any Hells Angels east of Ontario because all the Quebec Hells Angels were arrested in Operation SharQc.

Jeff Lynds ended up in a dispute with a drug dealer from Quebec named Louis (Le Gros) Vigeant. Vigeant claimed Lynds owed him \$40,000 and complained to Paul Sasquatch Porter who stripped Lynds of his patch. Lynds thought he could get his patch back if he settled his debt with

Vigeant or had him killed. Lynds orchestrated a few more murders and an attempted murder which just made the situation worse.

So he loses his patch, fails to get it back, then starts cooperating with the police and starts ratting out people he hired to commit murders. Then people think the police faked his death and he entered Witness Protection. That's messed up. In the police's defense, at least they solved the murders.

In Quebec, several Hells Angels hitmen ended up cooperating with the police. That's because hitmen aren't money makers like drug dealers they're liabilities because they know too much. That's why the Hells Angels often hire someone to kill their own hitmen to cover their tracks.

That's why Yves "Apache" Trudeau ended up cooperating with the police. He survived the Lennoxville massacre and knew he was next.

Aimé Simard was another hitman turned informant as was Danny Kane. They became lovers and Danny Kane was found dead of an apparent suicide in 2000. Aimé Simard was found dead in his cell July 18th 2003. He was stabbed 187 times. So they claim. Simard was the one that requested the prison transfer to Prince Albert a few months before his death.

While investigating Gabe Wortman's ties to the Hells Angels and the RCMP, one local source claimed that they had faked Danny Kane's death as well as Aimé Simard's death and that they became a couple and lived happily ever after. They even sent me a picture which I posted with their faces blurred out.

The whole point here is the Ontario Hells Angels connection to the Quebec and Nova Scotia drug trade after all the Quebec members were in prison following Operation SharQc. That matters because it ties in with the betrayal of the Rizzutos in Montreal who Mom Boucher had always supported. It also ties in to the shootings of Ontario Nomads and why the Ontario Nomads were disbanded after the Quebec members got out of prison and wanted their territory back.

It also ties in with Stadnick and the Calabrians out of Hamilton who started a war with the Rizzutos in Montreal and explains why Larry Amero had two of his Quebec co accused brutally murdered in Colombia and Greece.

The Rizzuto war with the Calabrians in Ontario

The court transcripts from former hitman turned informant Robert Simpson explain the Jeff Lynds fiasco in Nova Scotia. Jeff Lynds wasn't from Nova Scotia. He was a Nomad from Ontario who went to sell drugs in Nova Scotia after all the Quebec members were busted in Operation SharQc.

Jeff f*cked up, owed a Quebec drug dealer money so Paul Sasquatch Porter stripped Lynds of his Hells Angels patch. Robert Simpson was Jeff Lynds body guard. After he loses his patch he tries killing more people to get it back. When that fails he decides to cooperate with the police then all of a sudden dies in prison. Locals think the police faked his death so he could enter Witness Protection.

Jeff Lynds confessed to shooting Randy Mersereau and ordering the murder of Kirk Mersereau along with his wife. Why is that? Because Jeff kicked Randy out of the club making him a rival. Rival to who? Rival to him. Randy and Kirk were selling for the Quebec members Jeff was Ontario.

This bizarre case clearly shows how the Ontario Nomads took over the Quebec members drug trade when they went to jail and explains why the Quebec members started shooting them when they got out of jail and wouldn't give them their drug territory back.

Confirming the reason the Ontario Nomads were disbanded and Damion Ryan was farmed out to Greece. Which sheds light on the reason Damion Ryan and Robby Alkhail murdered that Quebec member in Greece that came to them for help when Larry Amero got busted. As well as the other

Quebec member Skinner murdered for Larry in Colombia. Only Skinner wasn't Larry's contact, he was Stadnick's contact.

Which explains why the CSIS podcaster is defaming Mr Worldwide, Martin Robert. Martin Robert was loyal to the Rizzuttos while Standick embraced Larry Amero in Ontario to push the Rizzuto betrayal in Quebec in favor of the Calabrians from Hamilton where Stadnick is also originally from.

So that's where we're at. At first I thought Larry Amero was delusional for brutally murdering two Quebec members. Now I realize Stadnick was behind it. That whole drug bust claiming Wheels was a high ranking member of the West End gang was a ridiculous lie.

Shane Baloney is from Burnaby not Montreal. He is the illegitimate son of a waitress. Shane used to rip people off here. He has no legacy. Neither does Larry Amero. Larry Amero isn't from the hood. He's from a suburb in Langley called Walnut Grove. He was a rich kid who used to drive for the rats to do B&Es and liked to brag about wearing designer jeans. He was best friends with Jonathan Bacon who was a preppy a*s b*tch.

So clearly the Five Eyes have been working overtime blowing up Larry and Shane into much more than they really are back east. As I said at the time, the Rizzuto murder when a sniper shot him dead in front of his family at the dinner table was not a Mafia hit. That was the Five Eyes.

Not only does Walter Stadnick support the Calabrian takeover of the Rizzuttos in Quebec, so do the Five Eyes. You heard it here first.

Candace Owens and Tucker Carlson

Let's talk about Candace Owens and Tucker Carlson's rise to fame and how the mainstream media portrays them. Obviously Tucker Carlson's viral rise in popularity is tied to that of Candace Owens but first I want to zero in on how the mainstream media's portrayal of Tucker Carlson has changed.

As we know, Tucker Carlson started off as a Fox News host. I realize people coined the phrase Fox Fake News almost as much as the term CNN fake news. Fox News portrayed itself as a right wing media outlet for Conservatives but aligned itself with Neo Con fake Conservatives. We saw this during Trump's first term.

In Trump's first term, Fox News embraced Neo Cons like Mitt Romney who were in bed with Biden's dirty business deals in the Ukraine and trashed Trump. It's important to remember that.

It wasn't until Trump dominated and secured the Republican nomination in his second term that their coverage of him started to become slightly more favorable.

Let's also remember how the media portrayed Trump in his first term has completely changed from his second term. One could claim that it's partly due to the Conrad Black syndrome.

Conrad Black was a right wing media mogul that started buying up all the newspapers in Canada. As a result, the media's coverage of the news changed and reflected a different bias. That's the problem with media mergers.

Once you merge all the media outlets into one entity, they become much easier to control. Change the ownership and you change the news. Yet with Trump 2.0 it's more than that and it's not that.

For example, in Trump's first term the media trashed and attacked him every day. The Democrats obsessed over him and everything he said. Their obsession became unhealthy. They kept trying to impeach him for stupid things.

The Gaza genocide is a legitimate concern. Something Charlie Kirk questioned before he was murdered. The USS Liberty attack is a legitimate concern because it ties in with 9/11 and October 7th. President Johnston recalled the air support sent to protect them from that false flag attack.

Candace Owens also defiantly rails that all Freemasons traffic children. That's insane. I find it astounding how Candace can come up with so many intelligent arguments about so many things then throw logic out the window and make some claims that are absolutely false. It's astounding. We really need to rise above such ridiculous sweeping stereotypes.

So the Gaza genocide is bad. The unprovoked war with Iran is bad as is the unprovoked invasion of Lebanon. All we had to do was exactly what Margaret Thatcher did but we dropped the ball because the fake news still has a very dark agenda hell bent on enslaving us. So this is indeed the Alice in Wonderland Era where you have to be as Johnny Depp declared mad as a hatter to survive. It is the Age of Deception, Age of Extremism and Age of Atrocity. Health Challenges

I've been fortunate enough to have been blessed with good health my entire life. I have empathy for people with back problems. I know that can be very painful and chronic. In that sense I've been very fortunate.

One day I blew out my hip. It wasn't a gradual thing. It went from zero pain to severe pain instantly. It felt like someone was grinding a dental tool in my hip socket. They asked me at the time on a scale of one to ten how painful

it was. I said compared to what? Childbirth? I tough guy is going to say it doesn't hurt and a weasel is going to say 10. I said it hurts.

The doctor took one look at the xray and just shook his head. He said yeah that's bone on bone. You can't fix that. You're going to need a new hip. I was in denial. I don't have arthritis. I climb mountains. So I started looking at alternative medicine.

I got an inversion table. It made my back feel great, but it didn't help my hip. I tried supplements. Then the doctor sent me to a surgeon for a cortisone shot. He was quite young and I said you've done this before right. Oh yes he said. Turns out he wasn't the surgeon, he was someone else.

He said there was something like an 80% success rate from the injections. I was impressed and said let's try it. He gets this very long needle and sticks it into my hip. Afterwards I was in shock. There was no pain. I said was there freezing in that? Is this like the dentist where as soon as the freezing wears off the pain will return?

Turns out there was some local freezing but the pain didn't return for a week. Then all the pain came right back again. I was like I'm not doing that again. One week's not worth it. Then they said there was something else I could try. They could inject a gel into my hip socket to replace what's worn out. I said lets try it. It didn't work at all. I was choked.

I finally met with the surgeon and told him the other doctor told me the injections had an 80% success rate. He said the other doctor didn't lie. It did work. I just didn't last more than a week. The impression I had was that it was going to be a successful alternative to surgery. That was false.

So I wasted time on the wait list trying other things so I put myself on the cancellation list for a hip replacement. I started using a cane and by this time the pain was excruciating. Every step you could see the pain in my eyes. I remember attending Neil Cantrill's hearing in New Westminster. He had supporters in the crowd. I had a cane and could barely walk. I thought I

better leave early or these guys are going to jump me in the parking lot and I won't be able to do anything about it.

I see the surgeon and he tells me I'm using the cane wrong. My right hip was blown and I'd use the cane in my right hand like a crutch putting all my weight on it. He said if my right hip is blown I should be using the cane in my left hand to stabilize myself. I tried it and said I can't walk then. He said then you should be on crutches. I was like but I can't fit crutches on my motorcycle. What I was doing was hooking the cane on my handle bars and kept riding my motorcycle. It worked great.

The surgeon just shook his head and rolled his eyes. After his advice I started using two canes like crutches because I need them. They did fit on my motorcycle. Some people were giving me a hard time about riding my motorcycle and I said give it a rest. As soon as I get my foot up and am in motion I'm pain free. It's easier for me to get on and off my motorcycle than get in and out of a car.

I remember riding out to Pitt Lake one day looking at the canoes and kayaks crossing over to Wideon creek thinking I'd never be able to do that again. It was depressing. I had never had surgery before and was somewhat anxious. There was an older guy at work who had both hips replaced. He said it's not a big deal. I've had it done like six times. I was like WTF? He said he had both hips replaced but they were faulty and they had to do it again but he got a good settlement out of it.

I was like I don't want a settlement. I want it done right. He said one time he had an epidural and woke up during the procedure. This was not helping my anxiety about surgery. I was told I was having general anesthetic and was relieved. Then the day of the surgery the anesthesiologist met me and casually mentioned an epidural. Epidural I said? I thought I was having general. She said we find that an epidural is better for post surgery pain management. I was like I get that but a coworker said he woke up during the procedure when he had an epidural.

She was like oh yes, you'll wake up during the procedure but I'll be right here. I just looked at her and thought I don't give a f*ck if you're right there and said I just think waking up during the procedure is creepy. I guess she took heed and gave me a little more sedative. I didn't wake up until it was over and I was greatly relieved.

Right after she informed me about the epidural the guy in the bed next to me was joking with the nurse about how he woke up during his surgery right when the doctor was raising the hammer to hit the chisel and I just shuddered. Even the nurse in rehab laughed and said yeah everyone wakes up for the saw. This was my first surgery and I was scared.

Now I'm a lot more comfortable with it and know what to expect. I think it's easier for me now to see it like the dentist. You can hear the drill but you don't feel it because of the freezing. Before I had it done I couldn't understand that. Anyways I had it done and I've been pain free ever since. It was well worth it. I'm not supposed to run and I'm not supposed to skip, which sucks because that's how I used to cut weight. Now I have to ride the bicycle which is fine but it's not the same but it's worth it to be pain free.

Now I have vasculitis and it has been a real challenge. It started off as a rash in my lower legs like the measles. Then I'd wake up in the night having to run them under cold water because they were burning, the rash turned into burning open sores and I started to get very concerned.

We had a friend who is a doctor that had a similar problem and he lost his leg. My daughter had a friend who was a security guard who had his toe amputated. It got infected and they kept saying it was fine until they said oh now we have to amputate. So again I started getting very concerned.

I saw my doctor and he ran some blood tests. I didn't have diabetes so that was good. In all the cases where people lost limbs they had diabetes. So that was one good thing. I saw the doctor again and showed him my legs. He put me on prednisone, gave me an oral antibiotic and a referral to a

specialist. Another reason I was concerned was because when my mother was elderly she had something similar and that killed her.

She had problems with her legs and had to go to the hospital to be put on antibiotics through intravenous. She kept going in and out of the hospital until they said they needed to amputate her legs. She said nope and died.

My daughter kept bugging me to go to the hospital and kept saying chat gtp said this and that. I didn't want to go to the hospital in Surrey because I didn't think they'd know what to do. So I sent pictures to the specialist and asked to go on the cancellation list saying I was ready to go to the hospital.

My daughter kept pumping symptoms into chat GTP and I said ask them what they think it is. She says chat GTP says they can't give a diagnosis. I told her to tell chat GTP I don't want a diagnosis. I want a list of possible conditions it could be. Then I started Googling them and ruling them out one by one. They said vasculitis and I typed it into Google. When I saw the pictures I said that's it. That was the exact same rash that I had.

There were different kinds. I didn't have a fever but that rash was exact. I get in to see the specialist. She takes one look at it and says have you even heard of vasculitis? I say funny you should mention that. That's what Chat GTP said it was. Then I asked her about a cause. She said well if you kept asking Chat GTP they would have told you there are thousands of causes. Then I finish her sentence and say and sometimes they never determine the exact cause.

She bumps up the prednisone, sets up some follow up appointments and tells me if it gets any worse go straight to the hospital. She said don't go to Surrey because they don't have a dermatologist go to VGH. I asked about Royal Columbia and she said nope. They don't have one either. They have a special clinic for this kind of thing in Vancouver.

It got worse, I went to VGH and they said why are you here? I said I have vasculitis and the specialist said if it gets worse go to the hospital. It got

worse so now I'm here. The nurse said your doctor didn't want to see you and I kind of felt stupid because she was the one that said go to the hospital. I was a bit concerned because it was near Shaunassey and there were several Jewish pavilions at VGH.

It was during the Gaza genocide and invasion of Lebanon. I didn't want someone to read something I had written online then misdiagnose me and shaft me. There were drug addicts in emergency vomiting. She got a shot of free drugs and was on her way. Then there was the gender neutral bathrooms. It wasn't an all gender individual bathroom, it was a shared bathroom with stalls for men and women. I did not feel comfortable with that. It was weird.

They were charging me \$24 every four hours for parking and said it was a 5 to 8 hour wait. So I'm like I'm out and went home. The next morning I called the specialists' nurses line and they fit me right in. I said it's just burning and the sores are opening up. I could work before but I can't work now. She takes a look at it and says it looks infected. Takes a swab to be sure. Puts me on an antibiotic and gives me a referral to the specialists at the Vancouver clinic.

Swab confirms an infection, It was an MRA staff infection which is resistant to antibiotics so she doubles my dose. I call up the Vancouver clinic, tell them I'm ready to go to the hospital and ask to go on the cancellation list. They eventually call back and ask me if I can make an appointment the following month. I told them I can be there any time. She said how about tomorrow morning. I said I'll be there.

So that's how I jumped through the delays. There was a rheumatologist and a dermatologist there to see me. The rheumatologist spent some time with me to take my medical history and do an exam. He consults with the dermatologist who said the other specialist did everything right.

They were both calm and confident that they knew what I had and knew how to treat it. They weren't there to treat it, they were just there to consult

the GP and the specialist to advise on treatment and suggest some other possible meds to stop the burning.

I told the rheumatologist I wanted to stop the burning. I said in my mind, if it's burning it's not getting better it's getting worse. New sores are opening. If I can stop the burning I can start the healing. He said it's not that simple.

He was confident it was going to be OK but said it was going to take at least two months. I was burning up vacation time and had to apply for Manulife short term disability which I didn't want to do because it was only 80% of my wage and nobody can live off of 80%.

So that's where I'm at. It's not getting better, it's still burning all the time. I have to get up every few hours to rinse my legs with cold water to stop the burning, then douse the scabs with vaseline. It's very high maintenance and mentally draining. It is starting to affect me mentally.

I can't do anything. If I wrap my legs to go to the gym or run errands I'm good for about an hour. Then I have to unwrap them, rinse them off in cold water and cover them with Vaseline. I can't go hiking, I can't go kayaking. I can't do anything. I thought technically I could go to the beach and put my feet up but the thought of sand or fleas getting into the open sores concerns me. I don't want to go anywhere near that.

So I've been doing a bit of blogging. There has been a barrage of insane headlines in the news during Trump 2.0 with his unprovoked war with Iran that served as a diversion for Netanyahu's deplorable invasion of Lebanon. That's given me something to do between naps since there's nothing on Netflix. So this is an opportunity to write another eBook.

At first I wanted to write a book about three road trips on my motorcycle. I didn't want it to be about gangs or drugs. I wanted it to be about something positive. Yet the road trips keep getting postponed and I'm thinking maybe I should write two books. One about the road trips and the other about my

blog. Summarize what I've been blogging about for the past 14 years and the road ahead with all the insane gaslighting we're getting in the news.

So here we are. As I write this book my legs are burning and I have to keep dowsing them in cold water, hoping that the specialists are right and this too shall pass. I refuse to believe this condition is chronic. Yet it's not getting better and that scares the life out of me. This condition doesn't fit in with my life plan so it doesn't. I'm not supposed to retire until I'm 70.

CSIS, Air India, Bill Majcher and Cameron Ortis

I've talked about the Cameron Ortis case before and how it ties in with the Bill Majcher case. Two patriots were set up and betrayed by the Intelligence Community for similar but different reasons.

People didn't really know Cameron Ortis. He was young, fresh out of University with a PHD in cyber security. Cameron Ortis was hired shortly after William Elliott became Commissioner. Bob Paulson and Todd Sheen wanted to bring RCMP Intelligence up to snuff with the Five Eyes so they created the OR short for Operations Research to coincide with the NIC which was short for the National Intelligence Coordination Centre.

They put Ortis in charge of the OR because of Ortis' background in Cyber security. It's like if you want someone to be able to use AI, you need someone young. The same with cyber security.

The court transcripts described the rivalry between the OR and the NIC. When Ortis was put in charge of the NIC, that department lost their sh*t and trashed his office on his first day. They didn't want a civilian in charge of their department just like they didn't want a civilian for a commissioner.

So they started to do to Cameron what they did to William Elliott. They started a paper trail of bogus verbal abuse complaints. Ortis was a civilian.

He wasn't raised with the Depot abusive mentality. Bob Paulson and Todd Sheen knew it was BS. That's why they didn't pursue it.

They knew it was just push back from the old boys club. They just had no idea how far the old boys club would go to destroy Cameron's life and prevent him from becoming another civilian RCMP Commissioner.

When I first heard the allegations against Cameron Ortis I said no way because of where the allegations came from. It came from a former CIA agent. He claimed that Ortis was accused of selling state secrets to China. That was ridiculous. It was so ridiculous they quickly changed their story.

They took false allegations about China and pinned them on William Majcher, then they came up with new and even more ridiculous allegations about Ortis. They said he wasn't trying to sell state secrets to China, he was trying to sell them to a police mole named Ramos. William Majcher's case was a bit different. A lot of credible people knew him because they had worked with him for years. They saw the allegations for what they were, a complete set up. That made them concerned about government corruption. If they could set Bill up they could set anyone up. As a result, the case against Bill Majcher completely fell apart.

The court ruled his arrest was illegal and the search of his friend and associate Kim Marsh's home was illegal. Kim Marsh was named as an unindicted co-conspirator and wanted to testify to clear his name but the crown dropped their star witness and closed their case early.

The fractured case against Bill Majcher that wasn't solely based on a narrative from an Australian TV show involved the investigation of Kevin Sun who was accused of defrauding a Chinese bank of millions of dollars.

Kim Marsh's evidence was that he gave the RCMP information about Kevin Sun and the RCMP refused to investigate him. That was a huge red flag that forced everyone to ask why not? Who was Kevin Sun really working for? Was he a US Intelligence asset? It sure looked that way.

Then there was the FBI connection. Evidence in Bill Majcher's trial was an email the FBI intercepted from Bill's friend and associate Ross Gaffney who was a former FBI Agent Bill had worked with on some very successful high profile money laundering cases.

One in particular involved the conviction of a Canadian lawyer who had been laundering money for the Haney Hells Angels. Just like the concerns of Kim Marsh, Ross Gaffney had similar concerns. Ross Gaffney had given the FBI information they had found about Uranium One and once again, the FBI did nothing with it. Why not? Because it was tied to Hillary Clinton.

The Clintons used a Canadian shell company to sell weapons grade uranium to Russia. Instead of investigating that, they investigated Bill Majcher. Ross Gaffney went on their radar when he started speaking out about the politicization of the FBI. Bill Majcher went on their radar when he criticized the RCMP leadership in one of Paul Palango's books.

So again everyone that knew Bill Majcher knew this was a set up and it made them very concerned about government corruption. Cameron Ortis' case was a bit easier to fall through the cracks because he wasn't as well known in the Industry as Bill Majcher was. Yet he too was a patriot.

Yet Cam had friends who knew him too. One of which wrote an article in the National Post under the headline What if he's innocent? That's an important question because if Cameron Ortis is innocent like Bill Majcher that reflects government corruption tied to CSIS and the Five Eyes.

Let's not forget CSIS created the Heritage Front and provided the explosives for Air India. That's important. Let's not forget that CSIS was created after a decade of RCMP dirty tricks and false flag attacks and that

CSIS's first order of business was to continue that longstanding tradition. This is the paper trail that's led to where we are now.

Today the judge is announcing her verdict in the Bill Majcher case and CTV launched a deplorable hit piece on Bill filled with CSIS propaganda. In the CSIS Strikes Back article they admit there was a Memorandum of Understanding between the government of China and the Canadian government with regards to investigating criminals under proceeds of crime. They admit that and sound the alarm about something else.

The hit piece went off about China going after dissidents knowing full well that had absolutely nothing to do with Bill Majcher or his case. Yet they made it look like it did knowing it didn't. That is defamation with malicious intent. Paid for by your tax dollars and the fake news. Bill Majcher's case was solely about Kevin Sun who was accused of defrauding a bank in China of millions of dollars. He was no dissident or activist.

So the results are in. Bill Majcher was found not guilty! Now this certainly does open Pandora's box. One of Cameron Ortis' friends wrote an article in the National Post asking What if he's innocent? That's an important question because if he is innocent, like Bill Majcher is, that reflects government corruption tied to CSIS and the Five Eyes which should trigger a Public Inquiry. CSIS needs to be investigated for many crimes.

CSIS provided the explosives for the Air India bombing through their agent Surjan Singh Gill who helped plan it and nothing was ever done about it.

I stand as a witness and declare that CSIS and the Five Eyes are tied to the extortion in Surrey and Brampton as well as the murder of Hardeep Singh Nijjar and Ripudaman Singh Malik. This needs to be investigated.

Cameron Ortis was also innocent. Due to trial delays from a long list of RCMP dirty tricks, he was paroled before his appeal was heard.

The RCMP falsified evidence against him. All those crazy passwords they claim he had were lies. They made up those ridiculous passwords with the sole intent of defaming him. They also destroyed him financially.

The CIA crashed the BCCI through arms dealing, money laundering and drug trafficking. The same with the Nugan Hand Ltd. in Australia which was described in Jonathan Kwitny's book the Crimes of Patriots: A True Tale of Dope, Dirty Money, and the CIA. For me, the Gary Webb story was the light that went on in the same way as the Hells Angel I met enforcing for the crack dealers in Surrey Central.

Terry Reed's book Compromised: Clinton, Bush and the CIA is another tell all tale about the CIA's long history with drug trafficking. As is Gary Webb's book Dark Alliance. My point is, it's not just drug trafficking. It's money laundering and fraud as well and as we see in Surrey and Brampton it now also includes extortion. Where there's a will there's a way for the CIA to make money through nefarious means.

What can we do? Wait 'till I tell ye. The first thing we can do is take the blinders off. Blind obedience to anything is blind. When we see such bizarre extremism come from the far left and now the far right, we have to rise above this cult-like devotion to partisan politics.

Far right is the same as far left. Corruption and Globalization infiltrates both sides of the political spectrum. You can't Unite the Right because if you unite with the far right you have to abandon your core principles and thereby become what you set out to oppose. Neo Cons use false flag attacks as a pretext for war and to justify taking away civil liberty.
